1. Where is **THE MAVRICK LOCATED?**

2. What are the available plot sizes?
Answer: 250sqm and 500sqm
3. Is there any encumbrance on the Land?
Answer: No, the land is free from any known government acquisition or interest and adverse claims. The Title is Registered Deed of Settlement & Registered Survey Plan.
4. What is the price of Cornerpiece plot?
Answer: Attracts additional 25% charge.
5. What do I get after payment for the land?
