- Question: Where is Medorf Residence located?
 Answer: Medorf Residence is located at GRA, Alagbaka, Akure.
- Question: Is there any encumbrance on the houses?
 Answer: No. The Land where the houses are built is also free from any government acquisition or adverse claim.
- 3. Question: What type of houses are on offer? Answer: Semi Detached 3 Bedroom + BQ.
- 4. Question: What is the payment structure?

Answer: After the initial payment, you are supposed to pay the balance monthly.
